



**7th Annual Juried
Miniature Show and Sale
January 31 – February 18, 2012**

The Art Exchange is pleased to announce our 7th Annual Juried Miniature Show. An opening reception will be held on Friday, February 3, at 7:30pm. The entry form is available at www.theartexchange.ca, or at The Art Exchange. Entries must be in on or before Saturday, January 21, 2011. Prizes will be awarded, for the top 3 entries, the evening of the opening reception. The call is open to all visual artists.

Artwork Submission Guidelines

- All submissions must be originals to be juried (no jpegs slides or photographs of work will be accepted).
- All media is acceptable
- Up to two entries per artist.
- Two dimensional works must be 3 x 4 inches and will not exceed 1/8 inch in depth.
- Three dimensional work must not exceed 3 x 4 x 3 inches.
- The artist's name, title, medium and an arrow indicating the top of the work must be clearly marked on the back of each piece
- A one page bio and/or CV must be included.

Entry Fee

A **\$22** (HST included) and non-refundable entry fee per piece will apply.

Framing

Artwork submitted must be matted with a white acid free mat, exactly 8 x 10". Mattes may be obtained at The Art Exchange for \$2.00 each. The Art Exchange will frame each piece for the duration of the exhibition. If the artist wishes, frames may be purchased after the exhibition for \$25 + HST.

Shipping

Entries may be delivered in person, by mail or courier. Include a 9 x 12" self addressed, stamped envelope or appropriate packaging, for the return of work submitted. It is the artist's responsibility to arrange for the return of the works (accepted or unaccepted) either by a SASE or other means, after the closing of the show on February 19, 2011. The Art Exchange will not be responsible for work left over 30 days.

Commission

All work submitted must be for sale. The Art Exchange will take a commission of 40% based on the retail price specified by the artist on the entry form. The minimum selling price is \$65. Unsold work and payment for sold work will be mailed to the artist in the SASE provided within 30 days of the close of the exhibition.

Liability

The Art Exchange will insure the works against loss or damage for the duration of the exhibitions for 60% of the retail price up to \$300 per artist. The Art Exchange will not be liable for works in transit.
